

EXISTING PURCHASER LOYALTY OFFERS - TERMS & CONDITIONS

With two exciting programs on offer, subject to conditions, existing purchasers can:

- Receive a \$5,000 discount off their repeat purchase of titled land in Pinnacle when entering into a new Land Contract of Sale, or

This must be done prior to the Referee entering a Land Contract of Sale. The Referee's details will be checked with our appointed agents and against those who have registered with Pinnacle to see if in they have registered to our mailing list in the last three (3) months ('the Pinnacle Database). The Referrer will then be advised if that family member/friend is eligible.
 - If not on the Pinnacle Database, the Referee will be added. It is the responsibility of the Referrer to ensure that they advise the Referee of this offer and that they will be added to the Pinnacle Database.
 - If deemed an eligible Referee, the Referee must enter into a Land Contract of Sale before the cut-off date.
 - The Referee must pay a 5% deposit is paid at the time of signing.
 - The Referee settles on the land no more than 90 days from the Day of Sale.
 - The Referee foregoes the right to nominate under the Contract of Sale and any conditions allowing for such are removed from the Contract of Sale.
 - Following settlement, the Referrer contacts our appointed agents (Buxton, Ballarat) within 14 days to claim your pre-paid Visa. The pre-paid Visa will be provided to the Referrer within 30 days of settlement.
